

**ROUND MOUNTAIN WATER AND SANITATION DISTRICT
RESOLUTION NUMBER 2020-05**

**A RESOLUTION APPROVING NEW RATES AND FEES FOR WATER AND
WASTEWATER SERVICE, MAKING CHANGES TO SECTION 5 OF
RESOLUTION 1975-01 AND RENAMING RESOLUTION-01.**

WHEREAS, Round Mountain Water and Sanitation District (District) has completed a comprehensive rate structure and fee schedule study, and

WHEREAS, the results of the rate study and the District Board of Directors conclude that existing billing rates and fees are insufficient to finance current and future needs of the District, and

WHEREAS, on January 30, 2020, after a 30-day public notice period, a public hearing was held to allow the public an opportunity to become informed, ask questions and provide comments regarding the proposed change to the rate setting process and proposed rate increases.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE
ROUND MOUNTAIN WATER AND SANITATION DISTRICT, COLORADO THAT:**

Item 1 – RESOLUTION 1975-01 shall from this point forward be known as the “ROUND MOUNTAIN WATER AND SANITATION DISTRICT’S RULES AND REGULATIONS” hereinafter referred to as the “RULES AND REGULATIONS”.

Item 2 – New Water and Wastewater Rates and Fees, as shown on Attachment A to this resolution which will be known as Appendix A to the RULES AND REGULATIONS hereby adopted and shall be effective as of March 1, 2020. This rate schedule will be instituted and will supersede all prior rate and fee schedules.


Item 3 – Changes to Article 5 of the Rules and Regulations shall be made as shown on Attachment B to this resolution.
